ADVISORY TO ALL STUDENTS, FACULTY MEMBERS, AND STAFF

Subject: Prohibition of Public Meetings, Processions, Demonstrations, and Protests within the College Campus- Compliance Advisory

This is to bring to the notice of all students, faculty members, and staff of College of Vocational Studies, University of Delhi, that the Office of the Proctor, University of Delhi, vide Ref. No. PCTO/2026/ dated 17.02.2026, has issued an Order strictly prohibiting public meetings, processions, demonstrations, and protests of any kind within the University Campus for a period of one month with effect from 17th February 2026.

The said Order has been issued in cognizance of information received that unrestricted public gatherings and demonstrations may lead to obstruction of traffic, threats to human life, and disturbance of public peace within the campus. This Order is also in consonance with the directions of the Assistant Commissioner of Police, Sub-Division Civil Lines, Delhi, vide Order No. 18441-18550/R/ACP/Civil Lines, dated 26.12.2025.

In accordance with the above, the following activities are strictly prohibited within the college campus premises:

- i. Holding of any public meeting, rally, dharna, protest, or agitation.
- ii. Assembly of five or more persons.
- iii. Carrying of any hazardous materials, including Mashals/Beacons/Torches, etc.
- iv. Engaging in any activity that may affect the general tranquillity of the public or the smooth flow of traffic.
- v. Shouting of slogans and making speeches.

All students, faculty members, and staff are advised to take note of the above instructions and ensure strict compliance. Any violation of this Order shall be viewed seriously and shall invite disciplinary action as per the applicable rules and regulations of the University of Delhi.

Additionally, students are advised:

- To maintain discipline, peace, and harmony on campus at all times. Participation in or organisation of any activity that may lead to disruption of academic functioning or disturb the social environment of the college or university will attract strict disciplinary action as per University rules.
- To avoid participation of individuals from outside the college in any campus-related activities, gatherings, or events without prior official approval from the College administration.
- Not to post, share, or circulate any controversial, sensitive, or provocative content on social media platforms or WhatsApp groups that may disturb harmony, create discord, or affect the peaceful environment of the college. Responsible and respectful online conduct is expected from all students.



Regarding posts on the official social media platforms of College of Vocational Studies, it is hereby clarified that:

- Only content/posts received through the designated Convenors/authorised faculty coordinators will be accepted.
- Posts sent directly by students will not be entertained.
- All content must be verified and approved by the concerned Convenor(s) prior to submission to the College's official Instagram account.
- Any content received without proper authorisation and verification will not be posted.

All students are requested to cooperate with the administration and uphold the dignity and reputation of the college and the University of Delhi. The Hon'ble Vice Chancellor has also urged all members of the University community to maintain harmony, avoid discord, and respect institutional processes while awaiting decisions on relevant regulatory matters. This advisory is issued in the interest of maintaining peace, discipline, and a conducive academic environment within the college and university premises.

All concerned are requested to cooperate fully with the administration in adherence to this Order.
